Then there could be issues with the "Right to Know" Laws.

- --Terry is going to try to get hold of the United for Libraries video on Social Media Policies, and check online for other Libraries that have Online Book Groups (NCW Libraries Washington State)

- One of the committee's thoughts is to make the Library furniture more movable, either with better wheels and/or changing the Big Table in the front room for two smaller tables.
- -Nancy reported on the Fire Department alarm over the weekend during our monsoon. Water was coming down though one of the fire alarms. The FD has determined that the smoke alarm is not needed where it is, so doesn't need to be replaced but the leak still needs to be found and fixed.
- Budget season starts soon and we need to work on requests for Warrant articles.

- --The individual who did the Richards Free Library would be willing to help we don't have a cost.
